Volunteer understands that this release discharges <u>MAM-WABC</u> from any liability claims that the Volunteer may have against <u>MAM-WABC</u> with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities with <u>MAM-WABC</u>, whether caused by the negligence of <u>MAM-WABC</u> or its officers, directors, employees, members of the board of directors, or otherwise. Volunteer also understands that <u>MAM-WABC</u> does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

- **2. Medical Treatment.** Volunteer does hereby release and forever discharge <u>MAM-WABC</u> from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's activities with <u>MAM-WABC</u>.

Volunteer expressly agrees that this release is intended to be as broad and inclusive as permitted by the laws of the State of Arkansas, and that this release shall be governed by and interpreted in accordance with the laws of the State of Arkansas. Volunteer agrees that in the event that any clause or provision of this release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this release, which shall continue to be enforceable.
